# Enter your nomination into one of the below categories

See how your cause aligns to Aviva's sustainability ambitions

Any broker employee in Ireland can enter either a charity or community organisation into one of the three categories. Each category has a top prize of €20,000.



## Climate Action

This category is for projects that help to make an improvement to either local biodiversity, or wider climate and environmental issues. This could include energy efficiencies in a publicly used building to help reduce overall operational carbon emissions like LED lighting or solar panels or building a nature walkway in the local community supporting local bird and insect populations.



### Examples

- Installation of greener energy source for community building e.g. solar panels, LED lighting for better energy efficiency.
- Local nature trail to support biodiversity in the area or an urban garden/community garden.
- Local tidy towns or volunteer clean up project e.g. beach clean ups.
- Environmental charity with a national or regional project that supports wildlife, trees, clean coasts, education, etc.
- Educational environmental group that teaches locality/school children about nature/biodiversity.



## Stronger Communities

The resilience of our local communities has been tested in recent years, between the Covid Pandemic and the current cost-of-living crisis. This category is for projects that help to strengthen our communities and support the people that live in them. Resilience may take the form of health and well-being, preventing loneliness or building financial resilience.



### Examples

- Community groups that are helping to make people more resilient e.g. supporting elderly people who may otherwise suffer from loneliness, or families suffering with grief.
- Projects to increase personal resilience e.g. workshops on mental well-being, suicide prevention charities.
- Projects to assist with financial resilience and well being e.g. groups supporting those struggling financially due to inflation and cost of living crisis.



## Diversity and Inclusion

It is important that we recognise the contributions that everyone in our society has to make and this category is for charities and community organisations that support and celebrate our differences. These might include charities working with neuro diversity and people with additional needs or organisations supporting the LGBTQI+ community.



### Examples

- Local community LGBTQI+ youth group projects.
- Charities supporting the inclusion of everybody in society especially marginalised and minority groups, or groups with additional needs.
- Community Group working with socially disadvantaged groups.
